Use Case Examples

The email screening is an intelligent automation solution to filter and identify communications which contain sensitive information for a compliance officer to investigate, while reducing the volume of false positives flagged to the compliance officer.

Emails to be reviewed are sent to a particular mailbox. The solution will then scan through all the emails in the mailbox and identify whether the emails contain any sensitive keywords. Any sensitive keywords found will be flagged and collated for further review by a compliance officer.

The Compliance Team has the flexibility to dynamically input the search criteria through a Web Form in a format of choice. This input can automatically trigger the screening process in the background. The team can also pre-configure these values in an excel and additionally schedule the process to run at any pre-decided and time of the day.
